

Part of the Tasmanian Institute of Sport (TIS), the Silverdome is a multi-purpose facility with a focus on sporting users, particularly netball and cycling. Procedures are in place to ensure that sporting users are given priority booking status of the facility; particularly the main arena and cycling track.

The Silverdome Complex has a range of rooms and areas available for hire and can cater for large and small sporting events, community events, meetings, training, exhibitions and concerts.

## LOCAL SEASON ROSTERS / REGULAR SPORTING USE

- Recovery of costs incurred – recovery for goods and services provided; including but not limited to; catering, wages, power, generator (if utilised), first aid and emergency coverage, cleaning, consumables.

Charges are negotiated by contract and are represented as an hourly rate, applicable from first entry to building to conclusion of hire.

## STATEWIDE AND NATIONAL ROSTERS / REGULAR SPORTING USE

- Venue hire fees may apply dependent on type of event and anticipated audience
- Recovery of costs incurred – recovery for goods and services provided; including but not limited to; catering, wages, power, generator (if utilised), first aid and emergency coverage, cleaning, consumables.

Charges are negotiated by contract and are represented as an hourly, daily or event rate.

## LARGER SPORTING AND SPORTS-RELATED EVENTS

- Venue hire fees apply and vary depending on type of event, audience numbers and ticket prices
- On-costs apply – cost recovery for services including but not limited to; catering, wages, ticketing, power, generator (if utilised), first aid and emergency coverage, cleaning, consumables
- Where tickets are sold on a hirer's behalf, an in-house fee may also apply
- Credit card charges apply.

Charges are negotiated by contract. All on-costs are fully itemised.

## PROFESSIONAL SPORTS ENTERTAINMENT

- Venue hire fees apply and vary depending on type of event, audience numbers and ticket prices
- On-costs apply – cost recovery for services including but not limited to; catering, wages, ticketing, power, generator (if utilised), security, first aid and emergency coverage, cleaning and consumables
- An in-house fee applies for all tickets sold
- Credit card charges apply.

Charges are negotiated by contract. All on-costs are fully itemised.

## NON-SPORTING USE

- Venue hire fees apply and are dependent on type of event, audience numbers and ticket prices
- On-costs apply – cost recovery for services including but not limited to; catering, wages, ticketing, power, first aid and emergency coverage, cleaning, consumables
- Where tickets are sold on a hirer's behalf, an in-house fee also applies
- Credit card charges apply.

Charges are negotiated by contract. All on-costs are fully itemised.

## NOT FOR PROFIT / COMMUNITY GROUP USES

- Nominal venue hire fee applies
- Recovery of costs incurred – recovery for goods and services provided; including but not limited to; catering, wages, power, first aid and emergency coverage, cleaning, consumables.

Charges are negotiated by contract. All on-costs are fully itemised.
